## NOTICE OF PUBLIC HEARING

**NOTICE IS HEREBY GIVEN THAT** the Yurok Tribe will hold three public hearings to accept comments from Yurok Tribal members on the following draft legislation:

- **Yurok Tribe Hemp Ordinance:** Amending the existing ordinance to maintain jurisdictional authority over hemp on the Yurok Reservation
- **Yurok Tribe Air Quality Ordinance and Smoke Management Plan:** Amending the existing ordinance and plan to add a cultural burn air quality permit, including a definition of “cultural fire practitioner;” input is especially requested for this definition.

The Yurok Tribal Council has referred to the above draft legislation to public hearing in accordance with the Yurok Tribal Public Hearing Ordinance. Public hearings are scheduled for:
