- different Tribe, is watching her destiny unfold. In the past 7 months, I have raised awareness
- about salmon, for our tribal elders' issues. I want to use this platform to raise awareness to the
- issues that are specific to Yurok. I am in graduate school. I would like to have a continuing
- relationship with the tribe. There are lots of issues I would like to address and work on, I want
- 203 to be a part of programs. I didn't get to this position alone and I won't be able to continue the
- work alone. Tribal Council and the Tribe has been a big supporter for my whole life. If you have
- any questions about anything I mentioned, please ask me.
